SECTION 4: First-Aid Measures

4.1. Description of first aid measures

First aid personnel should pay attention to their own safety. If the patient is likely to become unconscious, place and transport in stable sideways position (recovery position). 5.2. Special hazards arising from the substance or mixture

operators, whether spraying or not, have to work inside the spray booth, ventilation is unlikely to be sufficient to control particulates and solvent vapour in all cases. In such circumstances they should wear a compressed air-fed respirator during the spraying process and until such time as the particulates and solvent vapour concentration has fallen below the exposure limits. Avoid inhalation of vapour and spray mist. The workplace should be equipped with an emergency shower and eye-rinsing facility. Avoid contact with the skin, eyes and clothing. Protection against fire and explosion:
