SECTION 4: First-Aid Measures

4.1. Description of first aid measures

First aid personnel should pay attention to their own safety. If the patient is likely to become unconscious, place and transport in stable sideways position (recovery position). 5.2. Special hazards arising from the substance or mixture

SECTION 7: Handling and Storage

7.1. Precautions for safe handling

Provide good ventilation of working area (local exhaust ventilation if necessary). Do not return residues to the storage containers. Smoking, eating and drinking are forbidden in application area. For personal protection see section 8. Comply with the health and safety at work laws. When operators, whether spraying or not, have to work inside the spray booth, ventilation is unlikely to be sufficient to control particulates and solvent vapour in all cases. of vapour and spray mist. The workplace should be equipped with an emergency shower and eyerinsing facility. Avoid contact with the skin, eyes and clothing. Handle in accordance with good industrial hygiene and safety practice.

Protection against fire and explosion:

Avoid all sources of ignition: heat, sparks, open flame. Product may charge electrostatically: always use earthing leads when transferring from one container to another and earth containers. 8.2. Exposure controls

Acute toxicity

Assessment of acute toxicity:

Exposure to component solvent vapour concentrations in excess of the stated occupational exposure limit may result in adverse health effects such as mucous membrane and respiratory system irritation and adverse effect on kidney, liver and central nervous system. Symptoms and signs include headache, dizziness, fatigue, muscular weakness, drowsiness and in extreme cases, loss of consciousness. Repeated and prolonged exposure to solvents at levels significantly above OELs may lead to the development of long-lasting central nervous system disorders such as chronic toxic encephalopathy, signs of toxicity include changes in behaviour and memory. Solvents may cause some of the above effects by absorption through the skin. Repeated or prolonged contact with the preparation may cause removal of natural fat from the skin resulting in non-allergic contact dermatitis and absorption through the skin.
