# **SECTION 4: First-Aid Measures**

# 4.1. Description of first aid measures

First aid personnel should pay attention to their own safety. If the patient is likely to become unconscious, place and transport in stable sideways position (recovery position). Remove affected person from danger area. Keep warm, calm and covered up. Immediately remove contaminated clothing. Never give anything by mouth to an unconscious person. In case of intoxication, call a poison control center or physician for treatment advice, taking the packaging or the label of the product. Symptoms of poisoning may occur even after several hours, continue medical observation for at least 48 hours after the accident.

#### If inhaled:

# On contact with eyes:

Remove contact lenses, if present. Immediately wash affected eyes for at least 15 minutes under running water with eyelids held open, consult an eye specialist. Immediate medical attention required.

#### On ingestion:

Do not induce vomiting. Rinse mouth thoroughly with water, seek medical attention. If adverse health effects develop seek medical attention.

# 5.3. Advice for fire-fighters

Special protective equipment:

## 6.1. Personal precautions, protective equipment and emergency procedures

### 6.2. Environmental precautions

#### 6.3. Methods and material for containment and cleaning up

# **SECTION 7: Handling and Storage**

#### 7.1. Precautions for safe handling

Provide good ventilation of working area (local exhaust ventilation if necessary). Do not return residues to the storage containers. Smoking, eating and drinking are forbidden in application area. For personal protection see section 8. Comply with the health and safety at work laws. When operators, whether spraying or not, have to work inside the spray booth, ventilation is unlikely to be sufficient to control particulates and solvent vapour in all cases. In such circumstances they should wear a compressed air-fed respirator during the spraying process and until such time as the particulates and solvent vapour concentration has fallen below the exposure limits. Avoid inhalation of vapour and spray mist. The workplace should be equipped with an emergency shower and eyerinsing facility. Avoid contact with the skin, eyes and clothing. Avoid all sources of ignition: heat, sparks, open flame. Product may charge electrostatically: always use earthing leads when transferring from one container to another and earth containers. It is recommended that operators should wear antistatic clothing and footwear. Solvent vapours are heavier than air and spread along floors. Vapour forms explosive mixtures with air. The relevant fire protection measures should be noted. Use explosion-proof equipment.

# 8.2. Exposure controls

#### Appropriate engineering controls

Ensure adequate ventilation. This can be achieved by the use of local exhaust ventilation and good general extraction. If these are not sufficient to maintain concentrations at the workplace below the occupational exposure limits, appropriate certified respirators must be worn.
