## **SECTION 4: First-Aid Measures**

## 4.1. Description of first aid measures

First aid personnel should pay attention to their own safety. If the patient is likely to become unconscious, place and transport in stable sideways position (recovery position). Remove affected person from danger area. Keep warm, calm and covered up. Immediately remove contaminated clothing. Never give anything by mouth to an unconscious person. In case of intoxication, call a poison control center or physician for treatment advice, taking the packaging or the label of the product. Symptoms of poisoning may occur even after several hours, continue medical observation for at least 48 hours after the accident.

## **SECTION 7: Handling and Storage**

## 7.1. Precautions for safe handling

Provide good ventilation of working area (local exhaust ventilation if necessary). Do not return residues to the storage containers. Smoking, eating and drinking are forbidden in application area. For personal protection see section 8. Comply with the health and safety at work laws. Avoid inhalation of vapour and spray mist. The workplace should be equipped with an emergency shower and eye-rinsing facility. Avoid contact with the skin, eyes and clothing. Protection against fire and explosion:

It is recommended that operators should wear antistatic clothing and footwear. Solvent vapours are heavier than air and spread along floors. Vapour forms explosive mixtures with air.
