4. First-Aid Measures

Description of first aid measures

First aid personnel should pay attention to their own safety. If the patient is likely to become unconscious, place and transport in stable sideways position (recovery position). Remove affected person from danger area. Immediately remove contaminated clothing. In all cases of doubt, or when symptoms persist, seek medical attention. Avoid all sources of ignition: heat, sparks, open flame. Product may charge electrostatically: always use earthing leads when transferring from one container to another and earth containers.
