4. First-Aid Measures

Description of first aid measures

First aid personnel should pay attention to their own safety. If the patient is likely to become unconscious, place and transport in stable sideways position (recovery position). Remove affected person from danger area. Immediately remove contaminated clothing. In all cases of doubt, or when symptoms persist, seek medical attention. Never give anything by mouth to an unconscious person.

If inhaled:

Remove the affected individual into fresh air and keep the person calm. If symptoms persist, seek medical advice. If breathing is irregular or stopped, administer artificial respiration.

On skin contact:

If symptoms persist, seek medical advice. Remove contaminated clothing. Wash skin with soap and water, rinse abundantly. Do NOT use solvents or thinners.

On contact with eyes:

5. Fire-Fighting Measures

Extinguishing media

6. Accidental Release Measures

Personal precautions, protective equipment and emergency procedures

Avoid breathing vapours. For non-emergency personnel: Use personal protective clothing. Ensure adequate ventilation. Keep away from sources of ignition. 7. Handling and Storage

sufficient to control particulates and solvent vapour in all cases. In such circumstances they should wear a compressed air-fed respirator during the spraying process and until such time as the particulates and solvent vapour concentration has fallen below the exposure limits. Avoid inhalation of vapour and spray mist. The workplace should be equipped with an emergency shower and eyerinsing facility. Avoid contact with the skin, eyes and clothing. Handle in accordance with good industrial hygiene and safety practice.

Protection against fire and explosion:

Avoid all sources of ignition: heat, sparks, open flame. Product may charge electrostatically: always use earthing leads when transferring from one container to another and earth containers. It is recommended that operators should wear antistatic clothing and footwear. Solvent vapours are heavier than air and spread along floors. Vapour forms explosive mixtures with air.
