6. Accidental Release Measures

Personal precautions, protective equipment and emergency procedures

Avoid breathing vapours. For non-emergency personnel: Use personal protective clothing. Ensure adequate ventilation. Keep away from sources of ignition. 7. Handling and Storage

Precautions for safe handling

Provide good ventilation of working area (local exhaust ventilation if necessary). Do not return residues to the storage containers. Smoking, eating and drinking are forbidden in application area. For personal protection see section 8. Comply with the health and safety at work laws. When operators, whether spraying or not, have to work inside the spray booth, ventilation is unlikely to be sufficient to control particulates and solvent vapour in all cases. In such circumstances they should wear a compressed air-fed respirator during the spraying process and until such time as the particulates and solvent vapour concentration has fallen below the exposure limits.
